

## **TOPLINE CABINETRY LIMITED LIFETIME WARRANTY**

TopLine Cabinetry Ltd. warrants to the original consumer purchaser for as long as they own their home that the TopLine Cabinetry Ltd. products will be free from defects in material and workmanship, at the date of installation. This warranty is only applicable to products supplied and installed in single family residential dwellings by TopLine Cabinetry Ltd. or its preferred subcontract installers, and is not transferable to subsequent owners, unless otherwise specified. Warranty coverage does not come into effect until all products and services have been paid for in full.

This warranty shall become null and void if the cabinetry, finished products, counter tops, or accessories are in any way altered. Furthermore, this warranty will not apply to products damaged by misuse, neglect, abuse, acts of God, exposure to moisture, exposure to extreme temperatures, normal incidental deterioration such as nicks, scratches, abrasions, and natural aging whether resulting from the effects of normal wear and tear or abnormal use. Damages due to misuse, abuse, handling or cleaning, are the responsibility of the purchaser. Improper installation of supply-only cabinets will not be covered by warranty. In cases of warranty claim, TopLine Cabinetry Ltd. will elect, at the discretion of an authorized TopLine Cabinetry Ltd. representative, to either repair or replace the defective material or component, free of charge. This warranty does not cover the labour to remove and reinstall components such as fittings and appliances, or related materials not supplied by TopLine Cabinetry Ltd.

Warranty does not cover reasonable wood grain and colour variations, or products purchased without a finish. Sunlight, smoke, household cleaners, and other environmental conditions may also affect the colour over time. These variations are considered to be the nature of the material in relation to their environmental exposure and are not covered under this warranty.

In cases of replacement or addition of finished products, TopLine Cabinetry Ltd. will work to match exact colours using both original samples as well as current parts from your existing cabinetry. However, in some cases, replacement or add-on parts may not be an exact match to the original cabinetry due to environmental changes. Repairs or replacements may be contingent upon the current product offerings of styles and construction options within the TopLine Cabinetry Ltd. products at the time of the warranty claim. If a warranty claim is filed after a product is no longer in use, TopLine Cabinetry Ltd. reserves the right to replace the affected products using the current style offerings without replacing the existing unaffected products to match.

TopLine Cabinetry Ltd. reserves the right to alter design, specifications and material without obligation to make similar changes to products previously manufactured.

This lifetime limited warranty applies to all products purchased after January 1, 2009.
